RESOLUTION NO. SP- ~~1121~~ - 99

A RESOLUTION RATIFYING THE CONTRACT OF SECURITY SERVICES ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT REPRESENTED BY THE HONORABLE CITY MAYOR AND THE TOMCAT SECURITY SERVICES CORPORATION, A DULY ORGANIZED CORPORATION AND AUTHORIZING THE RELEASE OF FUNDS AS COMPENSATION THEREFOR, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, the City government, through the Honorable City Mayor Ismael A. Mathay, Jr., entered into a Contract of Security Services with the TOMCAT Security Service, represented by its General Manager;

WHEREAS, the parties in this contract covenanted, stipulated and agreed in Section 4 hereof that;

"x x x For and in consideration of the Agency's services during the effectivity of this contact, the CLIENT shall pay the agency a total sum of Eleven Thousand Pesos Only (P11,000.00) Philippine currency, per guard for twelve (12) hours service per day including Sundays and Holidays x x x."


WHEREAS, said contract expired on June 30, 1998 thereby obliging the city government in the amount of Six Hundred Forty Nine Thousand Pesos (P649,000.00) which is now due and demandable;

WHEREAS, the Honorable City Mayor can represent the city in its transaction and sign contracts only upon authority of the Sangguniang Panlungsod, which is likewise empowered to appropriate funds of the City government;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Contract of Security Services entered into by and between the City government, represented by the Honorable City Mayor and the Tomcat Security Services Corporation, a duly organized corporation, and authorizing the release of funds as compensation therefor, subject to existing auditing rules and regulations.
