A RESOLUTION REQUESTING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., TO GRANT FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE SPO1 LINO D. GARRA.

WHEREAS, SPO1 Lino D. Garra was a member of the Central Police District Command (CPDC), Philippine National Police (PNP), assigned at Station 9, Quezon City and in active duty for fifteen (15) years;

WHEREAS, on October 8, 1997, while performing his official duties, he was mercilessly shot thereby causing his instant death;

WHEREAS, the untimely demise of SPO1 Garra placed his family in an emotional as well as financial difficulties having no other member of the family who has sufficient means of livelihood to sustain their daily living and the educational expenses that may be incurred by their children;

WHEREAS, almost all the savings of SPO1 Garra have gone to the medical and funeral services, and his family now faces a bleak future;


WHEREAS, in recognition to the invaluable contribution of SPO1 Garra in the preservation of peace and order and public safety, it is appropriate for the City government to grant financial assistance to his family as a manifestation of care and great love;
