A RESOLUTION REQUESTING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., TO NEGOTIATE WITH THE OWNER/DEVELOPER OF PALMERA HOMES SUBDIVISION LOCATED AT BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY, TO TURN OVER TO THE CITY GOVERNMENT THE PARKS AND PLAYGROUNDS SPECIFIED AS LOT 3-C IN TRANSFER CERTIFICATE OF TITLE NUMBERED 363312 OF THE REGISTRY OF DEEDS OF QUEZON CITY.

NOW, THEREFORE,



