RESOLUTION NO. ~~SP-1232~~, 1999

A RESOLUTION EARNESTLY URGING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, TO FACILITATE THE PAYMENT OF FINANCIAL ASSISTANCE TO RETIREES FROM THE CENTRAL POLICE DISTRICT COMMAND AS PROVIDED FOR UNDER ORDINANCE NO. SP-154, S-94, AS AMENDED BY ORDINANCE NO. SP-222, S-94, FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, Ordinance No. SP-154, S-94, passed on January 25, 1994 as amended by Ordinance No. SP-222, S-94, provided "financial assistance by way of additional compulsory or optional retirement benefit to any member of the Central Police District Command (CPDC) who shall retire from the service; provided that, the retiree must not have been terminated from the police service thru administrative action and/or convicted of a crime involving moral turpitude and shall have served continuously the Central Police District Command for at least ten (10) years";


WHEREAS, some One Hundred Seventy Five (175) retirees from the CPDC have yet to receive their gratuities/financial assistance under Ordinance No. SP-154, S-94, as amended;

WHEREAS, the aforecited retirees, organized under the Central Police District Retirees (QCPD) Association, have requested the City government to provide available funds for their availment of the additional benefit under Ordinance No. SP-154, as amended;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby earnestly urge, the Honorable Ismael A. Mathay, Jr., City Mayor, to facilitate the payment of financial assistance to retirees from the Central Police District Command as provided for under Ordinance No. SP-154, S-94, as amended by Ordinance No. SP-222, S-94, from any available funds in the City Treasury.
