A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE HONORABLE CITY MAYOR, ISMAEL A. MATHAY, JR., AS THE FIRST PARTY AND GELIAN TRADING AND CONSTRUCTION, REPRESENTED BY ITS MANAGER, ELOISA A. SANTOS, AS THE SECOND PARTY, FOR THE IMPROVEMENT OF THE DRAINAGE SYSTEM AT BARANGAY BOTOCAN, QUEZON CITY, IN THE AMOUNT OF ONE HUNDRED THIRTY-SEVEN THOUSAND NINE HUNDRED AND TWO PESOS (P137,902.00) TO BE CHARGED AGAINST THE LINGAP FUNDS OF THE 1998 CITY BUDGET.


