WHEREAS, the Commission on Elections, through Resolution No. 3085 promulgated on June 18, 1999, has set on October 23, 1999 the conduct of the Plebiscite to ratify the creation of the City of Novaliches out of Quezon City, pursuant to RA 8535;

WHEREAS, the question before the voters of Quezon City in relation with the Plebiscite, will have a far reaching impact on their lives;

WHEREAS, in order to give City residents, particularly workers of private firms, the full opportunity to exercise their right of suffrage, there is a need to free them on said day of the responsibility of reporting for work;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby earnestly request, His Excellency, President Joseph E. Estrada, to declare October 23, 1999, Novaliches Cityhood Plebiscite Day, as a Non-Working Holiday in Quezon City in order to afford City residents, particularly workers of private firms, the full opportunity to participate and vote in the Plebiscite for the approval on the creation of the City of Novaliches out of Quezon City pursuant to R.A. 8535.


