A RESOLUTION GRANTING MONTHLY HONORARIA TO THE BOARD OF DIRECTORS, SET OF OFFICERS AND DISTRICT PRESIDENTS OF THE LIGA NG MGA BARANGAY, QUEZON CITY CHAPTER AND FOR OTHER PURPOSES.

Introduced by Councilors ALMARIO E. FRANCISCO, ELIZABETH A. DELARMENTE, ROMMEL R. ABESAMIS, GODOFREDO T. LIBAN II, JORGE L. BANAL, EUFEMIO C. LAGUMBAY MARCEL C. RILLO and BAYANI V. HIPOL.

WHEREAS, the members of the Board of Directors, set of officers and District Presidents of the Liga ng mga Barangay in Quezon City perform other duties and responsibilities over and above their functions as Punong Barangays;

WHEREAS, the Liga formulates policies and programs to give direction to the One Hundred Forty-Two (142) barangays of Quezon City to enable them to achieve their individual missions, visions and goals to uplift the quality of life of their respective constituents in consonance with the programs and policies of the National Government and of Quezon City;

WHEREAS, it is but fitting and proper to extend monthly honoraria to the Board of Directors, members, set of officers and District Presidents of the Liga ng mga Barangay;

WHEREAS, the present and prior years' annual budget of Quezon City provide a lump sum appropriation under the Special Projects of the Office of the City Mayor for the grant of honoraria to Liga directors and set of officers, only that there is no breakdown as to how much are to be received by each of them.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, monthly honoraria to the members of the Board of Directors, set of officers and District Presidents of the Liga ng mga Barangay, Quezon City Chapter, and for other purposes.
