RESOLUTION NO. ~~SP-1267~~, S-99

A RESOLUTION URGING ALL PRINCIPALS OF BOTH PUBLIC AND PRIVATE SCHOOLS AND HEADS OF GOVERNMENT AGENCIES AND OFFICES IN QUEZON CITY TO CONDUCT EARTHQUAKE DRILL REGULARLY FOR THEIR STUDENTS AND EMPLOYEES IN THE WAKE OF STRONG EARTHQUAKES HITTING TURKEY, GREECE AND MORE RECENTLY TAIWAN.

WHEREAS, devastating earthquakes successively struck Turkey, Greece and just recently a neighboring Taiwan;

WHEREAS, these earthquakes toppled buildings and other infrastructure and killed thousands of people in the above-mentioned countries;

WHEREAS, like Turkey, Greece and Taiwan, the Philippines is situated in the earthquake belt, areas which are prone to earthquake;

WHEREAS, scientists including Phivocs Director Raymundo Punongbayan were inclined to believe that a strong quake may also hit the Philippines;

WHEREAS, other countries like Japan have been conducting regular earthquake drills among their school children and office workers;

WHEREAS, through these drills school children and office workers will be prepared for any eventuality when a sudden earthquake hits the country.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, all principals of both public and private schools and heads of government agencies and offices in Quezon City to conduct earthquake drill regularly for their students and employees in the wake of strong earthquakes hitting Turkey, Greece and more recently Taiwan.
