RESOLUTION NO ~~SP-1298~~ S-99

A RESOLUTION RATIFYING THE CONTRACT OF SERVICE ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, REFERRED TO AS THE CLIENT AND THE PEREBAL SECURITY AND DETECTIVE AGENCY INC., REFERRED TO AS THE AGENCY.

WHEREAS, the Quezon City government, through the Honorable City Mayor, entered into a contract known as "Renewal of Security Service Contract" with the Perebal Security and Detective Agency, a duly organized Corporation existing under and by virtue of Philippine Laws, represented therein by its Vice President;

WHEREAS, the parties stipulated, covenanted and agreed in Section 3 thereof on the compensation for the service rendered therefor, a portion thereof states:

"xxx Provided that the sum of P617,062.50 as monthly contract rate for seventy-five (75) security guards shall be remitted to the agency not later than thirty (30) days following the period covered as money-in trust from which the agency shall actually pay the security guards to whom such amount is due. xxx"

WHEREAS, the parties further agreed in paragraph nine (9) of the contract, as follows:

"xxx This contract shall take effect starting on 01 January 1994 until 30 June 1994. xxx"

thus the same is now terminated obliging the City government of so much amount as compensation for the service rendered;


WHEREAS, the Honorable City Mayor can represent the City in its transaction and sign contracts only upon authority of the Sangguniang Panlungsod, who is likewise empowered to appropriate funds of the City government;

WHEREAS, there is a necessity to ratify the document denominated as "Renewal of Security Service Contract" entered into by and between the Quezon City government, thru its Mayor, Honorable Ismael A. Mathay, Jr., and the Perebal Security and Detective Agency, hence this Resolution.


NOW, THEREFORE,

BE IT RESOLVED, BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Contract of Service entered into by and between the Quezon City government, represented by the Honorable Ismael A. Mathay, Jr., City Mayor, referred to as the client, and the Perebal Security and Detective Agency Inc., referred to as the agency.
