A RESOLUTION URGING THE NATIONAL GOVERNMENT CENTER HOUSING PROJECT (NGCHP) AND HOUSING AND URBAN DEVELOPMENT COORDINATING COUNCIL (HUDCC) TO ALLOW A REPRESENTATIVE FROM THE SANGGUNIAN BARANGAY OF COMMONWEALTH AND THE UNITED VENDORS ASSOCIATION OF COMMONWEALTH TO SIT IN THE NATIONAL GOVERNMENT CENTER (NGC) PUBLIC MARKET COMMITTEE IN ORDER TO HAVE A REPRESENTATION THEREIN AND TO SAFEGUARD THEIR RANK AND THEIR LIVELIHOOD WELFARE AND INTEREST.

WHEREAS, this marketing movement is within their marketing sphere that their attention should not be bypassed and it is our obligation and duty to include them in this action;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the National Government Center Housing Project (NGCHP) and Housing and Urban Development Coordinating Council (HUDCC) to allow a representative from the Sanggunian Barangay of Commonwealth and the United Vendors Association of Commonwealth to sit in the National Government Center (NGC) Public Market Committee in order to have a representation therein and to safeguard their rank and their livelihood welfare and interest.
