RESOLUTION NO. SP- 1338 , 3-2000

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., TO INCLUDE IN THE LIST OF INFRASTRUCTURE PROJECTS TO BE UNDERTAKEN UNDER THE INFRASTRUCTURE PROGRAM OF THE CITY THE REPAIR OF THE DRAINAGE SYSTEM AT THE LEFT SIDE OF ALIBANGBANG STREET FROM PALOMARIA STREET TO KALAMANSANAY STREET, BARANGAY VETERANS VILLAGE, QUEZON CITY, THE AMOUNT OF TWO HUNDRED EIGHTEEN THOUSAND FIVE HUNDRED SEVENTY-SEVEN PESOS (P218,577.00) NEEDED THEREFOR TO BE CHARGED AGAINST THE CITY DEVELOPMENT FUND OF THE CITY'S ANNUAL BUDGET FOR FISCAL YEAR 2000.

WHEREAS, on September 21, 1998, the Barangay Council of Barangay Veterans Village adopted another resolution, Barangay Resolution No. 49, series of 1998, requesting the Quezon City Council to appropriate funds for the repair and improvement of the drainage system at the left side of Alibangbang Street from Palomaria Street to Kalamansanay Street;

WHEREAS, as per estimate and program of works conducted and prepared by the City Engineer's Office, this City, the said projects/improvements will cost Two Hundred Eighteen Thousand Five Hundred Seventy-Seven Pesos (P218,577.00), copy of the individual project's program of work is hereto attached;

WHEREAS, this project is very necessary in order to avoid or prevent flooding in the area and its immediate vicinity;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the City Mayor, Honorable Ismael A. Mathay, Jr., to include in the list of infrastructure projects to be undertaken under the infrastructure program of the City the repair of the drainage system at the left side of Alibangbang Street from Palomaria Street to Kalamansay Street, Barangay Veterans Village, Quezon City, the amount of Two Hundred Eighteen Thousand Five Hundred Seventy-Seven Pesos (P218,577.00) needed therefor to be charged against the City Development Fund of the City's Annual Budget for Fiscal Year 2000.
