RESOLUTION NO. SP- **1385**-S-2000

A RESOLUTION RATIFYING THE CONTRACT (ANNEX "P") ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR., AND GELIAN TRADING AND CONSTRUCTION, REPRESENTED BY ITS GENERAL MANAGER, MS. ELOISA A. SANTOS, FOR THE REPAIR AND IMPROVEMENT OF FIRE STATION I OFFICE (PHASE I), QUEZON CITY, IN THE AMOUNT OF FIVE HUNDRED EIGHTY-ONE THOUSAND FIFTY-TWO PESOS AND 6/100 (P581,052.06), DOCKETED AS DOC. NO. 453, PAGE NO. 91, BOOK NO. XXVIII, SERIES OF 1999 OF THE NOTARIAL REGISTER OF NOTARY PUBLIC GODOFREDO T. LIBAN II.

Santos, for the repair and improvement of Fire Station I Office (Phase I), Quezon City, in the amount of Five Hundred Eighty-One Thousand Fifty-Two Pesos and 6/100 (P581,052.06), as evidenced by a copy of said Contract hereto attached as Annex "P" to form an integral part hereof;

WHEREAS, it appearing that the negotiated Contract (Annex "P") is regular in all respect, hence, the same may be ratified by the City Council;


NOW, THEREFORE,
