A RESOLUTION AUTHORIZING MAYOR ISMAEL A. MATHAY, JR., TO ENTER INTO NEGOTIATED CONTRACT/S FOR VARIOUS PROJECTS IN ACCORDANCE WITH THE PROGRAMS OF WORK AND AT SUCH AMOUNTS NOT EXCEEDING THE INDIVIDUAL PROJECT'S COST ESTIMATE ATTACHED AS ANNEXES "1" TO "5", TO BE CHARGED AGAINST THE FY 2000 LINGAP/COMMUNITY DEVELOPMENT FUND OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, the following proposed constructions, repairs, improvements/installations have been targeted to be undertaken, among others, by the City government to promote and enhance the safety, convenience and welfare of certain employees, affected residents and the general public, to wit:



BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, Mayor Ismael A. Mathay, Jr., to enter into negotiated contract/s for various projects in accordance with the programs of work and at such amounts not exceeding the individual project's cost estimate attached as Annexes "1" to "5", to be charged against the FY 2000 Lingap/Community Development Fund of the Office of the City Mayor.
