RESOLUTION NO. SP-1445 S-2000

A RESOLUTION URGING THE HONORABLE CITY MAYOR ISMAEL A. MATHAY, JR., TO PROVIDE HEALTH CARE BENEFITS, THRU THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), TO EXECUTIVE OFFICERS AND REGULAR BARANGAY SECURITY DEVELOPMENT OFFICERS (BSDO) AND ALLOCATING THE NECESSARY AMOUNT IN THE YEAR 2001 BUDGET AND EVERY YEAR THEREAFTER.

WHEREAS, the high cost of medicines and hospitalization charges have become prohibitive and not all can avail of such;

WHEREAS, some of our Barangay Executive Officers and Regular Barangay Security Development Officers (BSDO) belong to the low income group and thus can not avail of proper medical attention, care and hospitalization when the need arises;

WHEREAS, the Barangay Executive Officers and regular Barangay Security Development Officers (BSDO) perform a very important role in delivering basic and vital services in their respective communities;

WHEREAS, the Philippine Health Insurance Corporation (Philhealth), a government-owned and controlled corporation has offered a premium contribution scheme which is reasonable and affordable for employers and employees in the private and public sectors as well other individuals willing to avail on a voluntary basis;

WHEREAS, thru Philhealth, the Quezon City government can assure the Barangay Executive Officers and the regular Barangay Security Development Officers (BSDO) that in the event of illness they will receive proper medical attention and care;


NOW THEREFORE:
