RESOLUTION NO. SP- 1455 , S-2000

A RESOLUTION AUTHORIZING MAYOR ISMAEL A. MATHAY, JR., TO ENTER INTO NEGOTIATED CONTRACT/S FOR TWO (2) REPAIR/IMPROVEMENT PROJECTS IN ACCORDANCE WITH THE PROGRAMS OF WORK AND AT SUCH AMOUNTS NOT EXCEEDING THE INDIVIDUAL PROJECT'S COST ESTIMATE ATTACHED AS ANNEXES "1" AND "2", TO BE CHARGED AGAINST THE FY 2000 LINGAP/COMMUNITY DEVELOPMENT FUND.

WHEREAS, the following proposed repairs/improvements have been targeted to be undertaken, among others, by the City government to promote and enhance the safety, convenience and welfare of affected residents, and the general public, to wit:

WHEREAS, time is of the essence due to the urgency of the above proposed projects and the rising costs of labor and materials and to avoid unnecessary delay in attending to the normal conduct of public bidding, it is deemed expedient that the City government enters into negotiated contracts for the early completion of the above-stated projects;


