A RESOLUTION GRANTING AMUSEMENT TAX EXEMPTION TO THE BOY SCOUTS OF THE PHILIPPINES FOR THE SHOWING OF THE FILM "AYOS NA... ANG KASUNOD" AND "X-MEN" AT ALL SM CINEMAS IN QUEZON CITY ON OR ABOUT AUGUST 16, 2000 AND AUGUST 30, 2000, RESPECTIVELY, UNTIL THE LAST DAY OF SHOWING, PURSUANT TO SECTION 192 OF R.A. 7160, OTHERWISE KNOWN AS "THE LOCAL GOVERNMENT CODE OF 1991"

WHEREAS, the noble and laudable purposes of the Boy Scouts of the Philippines (BSP) deserve the full support of every Filipino and residents of the country, and every government office and agency, including the private sector;

WHEREAS, under Presidential Proclamation No. 20, dated September 23, 1998, the BSP was authorized to conduct a National Fund Campaign;

WHEREAS, the BSP Quezon City Council is conducting a Fund Drive to support the implementation of its program which are primarily leadership training, values formation and character building, drug prevention and environmental education;

WHEREAS, the grant of tax exemption from payment of amusement tax constitutes Quezon City's financial contribution to the BSP;


WHEREAS, the Office of the City Mayor as well as the Quezon City Council have in the past years granted the same tax exemption to the BSP;

WHEREAS, Section 192 of R.A. 7160, provides that local government units may, through ordinances duly approved, grant exemption, incentives or relief under such terms and conditions as they may deem necessary


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, amusement tax exemption to the Boy Scouts of the Philippines for the showing of the films "AYOS NA ... ANG KASUNOD" and "X MEN" at all SM Cinemas in Quezon City on or about August 16, 2000 and August 30, 2000, respectively, until the last day of showing, pursuant to Section 192 of R.A. 7160, otherwise known as "The Local Government Code of 1991"
