RESOLUTION NO. SP-487, S-2000

A RESOLUTION RATIFYING THE CONTRACT OF SECURITY SERVICES ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED HEREIN BY THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., AND TWINSTAR PROFESSIONAL PROTECTIVE SERVICES, INC., REPRESENTED HEREIN BY ITS PRESIDENT AND CHIEF OPERATING OFFICER, BRIG. GEN. ALEXANDER L. FELIX (AFP-RET).

WHEREAS, the Quezon City government through the City Mayor had entered into an agreement with Twinstar Professional Protective Services, Inc. wherein the latter will provide security services, subject to the following terms and conditions which they have agreed upon, copy of which is made integral part hereof, duly marked as Annex "A";


NOW, THEREFORE,
