RESOLUTION NO. SP-1489, S-2000

A RESOLUTION COMMENDING AND CONGRATULATING THE OFFICERS AND MEN OF THE CRIMINAL INVESTIGATION DIVISION (CID), CENTRAL POLICE DISTRICT (CPD) OFFICE AND STATION 8 FOR THEIR QUICK, RESPONSE TO THE TECHNOLOGICAL INSTITUTE OF THE PHILIPPINES (TIP) CUBAO BOMBING INCIDENT AND APPREHENSION OF THE SUSPECTS THAT LED TO THE EARLY SOLUTION OF THE CASE.

WHEREAS, in line with Mayor Ismael A. Mathay, Jr.'s Anti-Crime and Crime Prevention Program, the City Council is commending and congratulating the officers and men of the Criminal Investigation Division (CID), Central Police District (CPD) Office and Station 8 for their quick response to the Technological Institute of the Philippines' (TIP) Cubao bombing incident and apprehension of the suspects that for early solution of the case;

WHEREAS, barely an hour after the February 3, 2000 TIP Cubao bombing incident occurred, the CID-CPD men and officers of Station 8 headed by Col. Efren Fajardo Lagmay immediately proceeded to the crime scene, secured the area and conducted spot investigation;

WHEREAS, excellent joint effort of these officers and men plus sufficient intelligence work and efficient surveillance procedures led to the early solution of the bombing incident when two (2) suspects behind the bombing were finally arrested in Pasig City four (4) days after the incident;
