A RESOLUTION RATIFYING THE CONTRACT OF ABSOLUTE SALE MADE AND EXECUTED ON DECEMBER 5, 1996 IN QUEZON CITY BY AND BETWEEN THE QUEZON CITY GOVERNMENT, AS VENDOR, REPRESENTED BY ITS CITY MAYOR, ISMAEL A. MATHAY, JR., AND BUENAVENTURA GEPILA, AS VENDEE, AND ENTERED IN THE NOTARIAL REGISTER OF ATTY. FELIXBERTO F. ABAD AS DOC. NO. 470, PAGE NO. 95, BOOK NO. 3, SERIES OF 1997, UNDER WHICH CONTRACT THE QUEZON CITY GOVERNMENT, AS VENDOR, SELLS IN FAVOR OF MR. BUENAVENTURA GEPILA, A PARCEL OF LAND CONSISTING OF THREE HUNDRED THIRTEEN SQUARE METERS AND THIRTY-TWO SQUARE DECIMETERS (313.32 SQ.M.), THE SAME BEING APPROVED BY THE OFFICE OF THE PRESIDENT OF THE PHILIPPINES ON MAY 8, 1987 PURSUANT TO SECTION 25 OF P.D. 526, ALL SUCH DOCUMENTS ARE ATTACHED AND MADE AS INTEGRAL PARTS HEREOF.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Contract of Absolute Sale made and executed on December 5, 1996 in Quezon City by and between the Quezon City government, as Vendor, represented by its City Mayor, Ismael A. Mathay, Jr., and Mr. Buenaventura Gepila, as Vendee, and entered in the Notarial Register of Atty. Felixberto F. Abad as Doc. No. 470, Page No. 95, Book No. 3, Series of 1997, under which contract the Quezon City government, as vendor, sells in favor of Buenaventura Gepila, a parcel of land consisting of Three Hundred Thirteen square meters and Thirty-Two square decimeters (313.32 sq.m.), the same being approved by the Office of the President of the Philippines on May 8, 1987 pursuant to Section 25 of P.D. 526, all such documents are attached and made as integral parts hereof.
