A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO MRS. TOMASA C. JOSE, WHO RETIRED FROM THE GOVERNMENT SERVICE ON DECEMBER 29, 1999, UNDER THE OFFICE OF THE CITY SECRETARY, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE OFFICE OF THE CITY MAYOR IN THE ANNUAL BUDGET FOR FISCAL YEAR 2001.

WHEREAS, Mrs. Tomasa C. Jose had faithfully served Quezon City as Librarian III under the Office of the City Secretary, Quezon City;

WHEREAS, Mrs. Jose had served only thirteen (13) years which is not sufficient to entitle her to the full retirement benefits granted under existing law which requires a minimum of fifteen (15) years of service to be able to avail of such benefits, a copy of her service record is attached and form an integral part of this resolution;


WHEREAS, due to old age, Mrs. Jose is now experiencing health problem, thus, almost all of her life savings is dwindling because of her continuous medication;

WHEREAS, in recognition of her valuable, faithful and outstanding service to the people of Quezon City, it is only fair and just to extend to her financial assistance;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to Mrs. Tomasa C. Jose, who retired from the government service on December 29, 1999 under the Office of the City Secretary, Quezon City, in the amount of Thirty Thousand Pesos (P30,000.00), to be taken from the appropriation for Grants, Subsidies and Contributions under the office of the City Mayor in the Annual Budget for Fiscal Year 2001.
