RESOLUTION NO. SP-1625, S-2001

A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY HON. ISMAEL A. MATHAY, JR. AND GELIAN TRADING AND CONSTRUCTION, REPRESENTED BY MS. ELOISA A. SANTOS, FOR THE PROPOSED REPAIR AND RENOVATION OF THE PROJECT 7 BRANCH, QUEZON CITY PUBLIC LIBRARY, QUEZON CITY, IN THE AMOUNT OF TWO HUNDRED NINETY SIX THOUSAND EIGHT HUNDRED TWENTY-ONE PESOS AND TWELVE CENTAVOS (P296,821.12).

WHEREAS, after proper negotiations, the Quezon City government, represented by Hon. Ismael A. Mathay, Jr., executed a contract with the Gelian Trading and Construction, represented by Ms. Eloisa A. Santos in her capacity as General Manager for the repair and renovation of the Project 7 Branch, Quezon City Public Library located at Barangay Veterans Village, Quezon City in the amount of Two Hundred Ninety Six Thousand Eight Hundred Twenty-One Pesos and Twelve centavos (P296,821.12) as evidenced by a copy of said Contract hereto attached as Annex "A" to form an integral part hereof;

WHEREAS, it appearing that the above-stated contract (Annex "A") is regular in all respect, the same may be ratified by the City Council;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the said contract entered into by and between the Quezon City government, represented by Mayor Ismael A. Mathay, Jr., and Gelian Trading and Construction, represented by its General Manager, Ms. Eloisa A. Santos, for the proposed repair and renovation of the Project 7 Branch, Quezon City Public Library in the amount of Two Hundred Ninety Six Thousand Eight Hundred Twenty One Pesos and Twelve centavos (P296,821.12).
