RESOLUTION NO. SP- **2109**, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO PURCHASE ASSORTED MEDICINES FROM THE PHILIPPINE INTERNATIONAL TRADING CORPORATION (PITC) IN THE AMOUNT OF SIX MILLION FIVE HUNDRED THOUSAND PESOS (PHP 6,500,000.00) UTILIZING FUNDS ALLOCATED UNDER THE THREE BILLION PESO (P3,000,000,000.00) LOCAL GOVERNMENT EQUALIZATION FUND FOR 2001.

WHEREAS, it is a declared policy of the State to protect and promote the right to health of the people and instill health consciousness among them (Section 15, Article II, 1987 Philippine Constitution);

WHEREAS, the sangguniang panlungsod is vested with the power to propose and enact measures to guarantee, promote and preserve the health of the people;

WHEREAS, there is an urgent need to support the City's health services program by providing assorted medicines to our Health Department;

WHEREAS, the assorted medicines shall be made available to the public that will help in the reduction of mortality rates in the City;

Belmonte, Jr., City Mayor, Quezon City, to purchase assorted medicines from the Philippine International Trading Corporation (PITC) in the amount of Six Million Five Hundred Thousand Pesos (P6,500,000.00) utilizing funds allocated under the Three Billion Pesos (P3,000,000,000.00) Local Government Equalization Fund for 2001.
