RESOLUTION NO. SP-**2735**, 2005

A RESOLUTION ENJOINING ALL BARANGAYS WITHIN THE JURISDICTION OF QUEZON CITY TO ISSUE ONLY OFFICIALLY AUTHORIZED UNIFORM GOVERNMENT RECEIPTS IN ALL TRANSACTIONS INVOLVING INCOME, REVENUE, GRANTS, DONATIONS AND MONETARY BENEFITS FROM SOURCES WHATSOEVER OR WHOMSOEVER.

WHEREAS, the non-use of official receipts by some barangay officials in transactions involving income and revenue for barangay purposes has become a source of misunderstanding, intrigue and conflict of interest among the officials of the barangay;

WHEREAS, such situation if not checked and remedied at once, would open the floodgate of abuse and graft;

WHEREAS, one system of control mechanism that can effectively discourage any ill motives regarding income and revenue collections by the coffers of the barangay is the strict and rigid implementation of issuance of uniform official receipts for all monies, donations, grants, aids, assistance in cash or check from sources whatsoever or whomsoever, observing always such prescribed accounting and auditing rules and regulation.



NOW, THEREFORE,




