WHEREAS, there is a necessity to update the City's available data regarding the total population of Quezon City, Metro Manila;

WHEREAS, in the absence of an updated and reliable data, the exact number of populace of this City has been the subject of speculation, surmise and conjecture by several quarters;

WHEREAS, possession by the City government of an official, updated and reliable data on the total number of residents in its different barangays will greatly help in the direction and delivery of its basic services and other projects designed for the benefit and welfare of its constituents, not to mention the fact that said official information is necessary and vital among other purposes;

WHEREAS, in order that the City government will have in its possession an official, updated and reliable data on the exact number of inhabitants within its territorial jurisdiction, it is necessary that a census and survey in each and every barangay be immediately conducted.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to direct, as it does hereby direct, the Barangay Council of every barangay in Quezon City to conduct a census in their respective jurisdiction to determine the exact number of the present population of their respective barangays.

RESOLVED, FURTHER, to direct the Barangay Operations Center, this City, to coordinate, supervise and monitor this important activity and to ensure the involvement of all Barangay Officials in the conduct of this survey in their respective barangays.

RESOLVED, FINALLY, to require the Barangay Operations Center to coordinate with the Bureau of Census and Statistics and to use the latter Office's methods and forms in order that the result of this census and survey will gain official acceptance and recognition by the said Agency and other offices of the National Government.
