RESOLUTION NO. SP- 2758, S-2005

A RESOLUTION GRANTING THE ADDITIONAL THIRTY (30) ROUTE MEASURED CAPACITY (RMC) FOR THE OPERATION OF MOTORIZED TRICYCLES-FOR-HIRE WITHIN THE ROUTE COVERED BY BARANGAY SIKATUNA VILLAGE TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (BSV TODA) DISTRICT IV, THIS CITY.

WHEREAS, the Barangay Sikatuna Village TODA, has applied for the legalization program of the City government and has submitted on November 2004 the list of unfranchized (colorum) tricycles that have been operating within the said barangay and which were included in the inventory conducted by the Tricycle Franchising Board and Tricycle Regulatory Unit on March 28, 2003;

WHEREAS, as per the recommendation of Mrs. Margarita Toledo, the Chief of the Tricycle Regulation Unit, thirty (30) unfranchized (colorum) tricycles have completed the requirements and passed the guidelines for their legalization;

WHEREAS, the Barangay Sikatuna Village TODA represented by its President Jesus S. Alorro has appealed for the issuance of the barangay resolution, however, Barangay Captain Filemon San Antonio, up to the present, denied such appeal nevertheless the Tricycle Regulation Unit, after conducting its actual inspection, recommended to the Tricycle Franchizing Board, the approval for the legalization of the thirty (30) unfranchized (colorum) tricycles plying within the said barangay.

NOW, THEREFORE,


