A RESOLUTION GRANTING SPECIAL PERMIT TO THE GALLERA DE GUISON HERMANOS, INC. (LA LOMA COCKPIT), FOR THE OPERATION OF ITS BUSINESS FOR A PERIOD OF TWO (2) YEARS COVERING THE CALENDAR YEARS 2005 AND 2006 ACCORDANCE WITH EXISTING LAWS, RULES AND REGULATIONS, AND SUBJECT T0 THE PAYMENT 0FCORRESPONDING FEES TAXES. AND OTHER CHARGES THEREFOR.

WHEREAS, Gallera de Guison Hermanos, Inc. (La Loma Cockpit) was granted a Special Permit under Resolution SP No. 1918, S-2002 for a period of two (2) years covering 2003-2004;

WHEREAS, the said cockpit holds twelve (12) derbies every year and pintakasis three (3) days per week, i.e., every Thursdays, Fridays and Saturdays or a total of one hundred fifty-six (156) pintakasis;

WHEREAS, there is a need to renew its special permit granted by the City Council for the operation of its business;

WHEREAS, the grant of a Special Permit to Gallera De Guison Hermanos, Inc., (La Loma Cockpit) will mean continued remittance of the taxes, fees and other charges it currently remitts to the City government.
