A RESOLUTION STRONGLY REQUESTING THE PEDDLERS AND/OR VENDORS WHO PLY THEIR TRADE AT NIGHT TO SECURE POLICE CLEARANCE CERTIFICATE WHICH THEY SHOULD CARRY IN THEIR PERSONS WHILE ENGAGED IN THEIR BUSINESS.

WHEREAS, the prevalence of crimes committed during nighttime calls for preventive measures which could diminish, if not totally eradicate the incidence thereof;

WHEREAS, the usual occurrence of such crimes are crowded and busy places such as market places, sidewalks, major thoroughfares, and the like;

WHEREAS, there is a perceived presence of peddlers and/or vendors who ply their trade not only during daytime but also at night;


WHEREAS, said persons or unlawful elements to be peddlers and/or vendors on account of their trade can easily be made instruments if not actual perpetrators of crimes;
