A RESOLUTION RECOMMENDING TO THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR. THE HOLDING OF A "SUPER PALENGKE COMMERCIAL-INDUSTRIAL EXPOSITION" THAT WILL COINCIDE WITH THE 66TH ANNIVERSARY OF QUEZON CITY AND EVERY ANNIVERSARY THEREAFTER.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to recommend, as it does hereby recommend, to the Honorable City Mayor, Feliciano R Belmonte, Jr., the holding of a "Super Palengke Commercial-Industrial Exposition" from the period of August to October, and upon the discretion of His Honor, extend the same, in commemoration of the 66th Anniversary celebration of the Foundation Day of Quezon City and every anniversary thereafter, in which the commercial-industrial sectors within the territorial jurisdiction of Quezon City would be invited and encouraged, thru tax incentives, to actively participate in the celebration by putting booths wherein products would be available at a special discounted price (factory-priced) so as to attract the consumers not only in Quezon City but also of the neighboring cities.

RESOLVED, FURTHER, that a Special Committee, to be headed by the Honorable City Mayor Feliciano R. Belmonte, Jr. or his duly designated representative and whose membership shall include one (1) representative from the City Council, be constituted, for such purpose.

RESOLVED, FINALLY, that copies of this Resolution be furnished the office of the City Mayor, the Filipino-Chinese Chamber of Commerce, Quezon City, the accredited non-governmental organizations and all Barangay Chairmen of Quezon City.
