RESOLUTION NO. SP- 2805, S-2005

A RESOLUTION STRONGLY URGING ALL INDUSTRIAL AND COMMERCIAL ESTABLISHMENTS IN QUEZON CITY TO HAVE A PROGRAM FOR THE ANNUAL MEDICAL EXAMINATION OF ALL THEIR RESPECTIVE EMPLOYEES.

WHEREAS, the health and physical fitness of all workers in Quezon City are the concern of the City government;

WHEREAS, to attend to this concern of the Quezon City government, it is strongly urged that all industrial and commercial establishments located within the territorial boundaries of Quezon City shall submit all their regular employees to an annual medical examination, which will include, but not limited to, chest x-ray examination, laboratory test, VDRL and physical check-up.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, all industrial and commercial establishments in Quezon City to have a program for the annual medical examination of all their respective employees.


RESOLVED, FURTHER, that compliance with this Resolution shall be reported to the City's Industrial Relations Office by the owner and/or the General Manager and/or Personnel Officer of every industrial or commercial establishment concerned within ten (10) days after every annual medical examination.

RESOLVED, FINALLY, that this Resolution be given City-wide dissemination through the Industrial Relations Office among all industrial and commercial establishments in Quezon City.
