RESOLUTION NO. SP- **2818**, S-2005

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO CAUSE THE IMPLEMENTATION OF ORDINANCE NO. SP-1207, S-2002, AMENDING ORDINANCE NO. NC-223, S-91 WHICH PROVIDES FOR BURIAL BENEFITS TO BARANGAY OFFICIALS AND REGULAR MEMBERS OF BARANGAY TANOD BRIGADES AND APPROPRIATING THE NECESSARY FUNDS THEREFORE.

WHEREAS, Ordinance No. SP-1207 was enacted on December 3, 2002 and approved on January 21, 2003;

WHEREAS, this ordinance amended Section 2 of the previous Ordinance NC-223, S-91, changing the appropriated sum from Two Million Pesos (P2,000,000.00) to Three Million Pesos (P3,000,000.00), henceforth the burial benefits of all Barangay Officials and Barangay Tanod Brigades shall be Forty Thousand Pesos (P40,000.00);

WHEREAS, considering that this Ordinance had long been approved, the City Council firmly believed that, it is high time that the said Ordinance is properly implemented;

WHEREAS, this kind incentive given to deceased Barangay Officials as well as Barangay Tanods will truly help their loved-ones whom they left to be able to give them a decent interment;

WHEREAS, the City Council would like to extend their sympathy and condolences to the relatives of the deceased residents of Quezon City through this Ordinance.


