A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE HILARIO C. BAGUINO, BELOVED BARANGAY CAPTAIN OF BARANGAY BAHAY TORO, DISTRICT I, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00), THE SAME TO BE CHARGED TO GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2005 BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND IN THE CITY TREASURY.

WHEREAS, Hilario C. Baguino, beloved Barangay Captain of Barangay Bahay Toro, District I, this City, passed away to join his creator last 23 January 2004 at the age of sixty two (62);

WHEREAS, he was Barangay Captain of Barangay Bahay Toro for the critical period spanning six (6) years, from 1992 to 1998, Barangay Kagawad thereof for three (3) years, from 1989 to 1992, and Barangay Treasurer thereof for six (6) years, from 1960 to 1966. He spent his life serving his constituents until his untimely demise;

WHEREAS, his legacy will forever live on, be remembered and cherished, especially by his constituents, for his selfless contributions towards the development and progress of his barangay and the upliftment of the plight and living conditions of his people;

WHEREAS, as a token of gratitude to the loyal and humble services he sacrificed for his barangay, his constituents, and for the City as a whole, it is but appropriate for the City government to provide financial assistance to his family to at least ease the economic burden brought about by his untimely demise.
