RESOLUTION NO. SP- 2863 S-2005

A RESOLUTION REQUIRING THE RESIDENTS AND/OR WATER SUBSCRIBERS IN QUEZON CITY TO REPORT ANY WATER LEAK OR BUSTED PIPE OF THE MAYNILAD WATER SERVICES, INC. TO THE BARANGAY CHAIRMAN OF THE PLACE WHERE THE LEAK OR BUSTED PIPE IS LOCATED.

WHEREAS, leaks in the water pipes of Maynilad Water Services, Inc. are the main cause of contamination of potable tap water, low water pressure or service interruption of water supply in the City,

WHEREAS, there are many instances of leaks or busted pipes which are unattended for a long period of time, either because the Maynilad Water Services, Inc. is not aware thereof or just because of sheer inaction on its part;

WHEREAS, there is a need to mandate the residents of Quezon City, the water subscribers and government officials to report any leak or busted pipe to the Maynilad Water Services, Inc. and/or the MWSS concessionaire for quick detection and prompt institution of remedial measures.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to require, as it does hereby require, all residents of Quezon City and/or MWSS water subscribers to report any water leak or busted pipe of the Maynilad Water Services, Inc. to the Barangay Chairman of the place where the leak or busted pipe is located, immediately upon notice thereof.
