A RESOLUTION URGING THE CITY MAYOR TO ENJOIN THE OFFICE OF THE CITY ENGINEER TO PUT-UP AND PLACE BUILDING DIRECTORIES IN CONSPICUOUS PLACES OF THE QUEZON CITY HALL AND ITS PREMISES TO AID VISITORS IN FINDING THEIR WAY AROUND AND FOR OTHER PURPOSES.
