RESOLUTION NO. SP- 2869, S-2005

A RESOLUTION REQUIRING ALL BARANGAY CHAIRMEN OF QUEZON CITY TO SUBMIT A REPORT AS TO THE CONDITION OF FIRE HYDRANTS IN THEIR RESPECTIVE JURISDICTION.

WHEREAS, fire incidents are common nightmares which not only endanger the lives of the citizenry but, in a spark, literally destroy their hard-earned properties;

WHEREAS, the pitiful condition of existing fire hydrants which are either unserviceable, damaged or destroyed gravely delays the immediate and effective response of fire fighters to check such emergencies that sometimes lead to the unfortunate and unnecessary loss of lives and properties;

WHEREAS, the protection of life and property is one of the priority concerns of any government truly committed to the promotion and enhancement of the general welfare and interest of its citizenry;

WHEREAS, if only to assure the Quezon City citizenry that there will be available protection during break-out of fire incidents, fire protection facilities such as functioning and serviceable fire hydrants, among others, should be maintained in tip-top condition;


WHEREAS, there is a need to require all Barangay Chairmen of Quezon City to submit a list of existing fire hydrants within their barangay jurisdiction, stating thereof its condition, whether serviceable or unserviceable, for determination whether the same should be replaced or repaired when necessary, or so as the case may be.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to require, as it does hereby require, that all Barangay Chairmen of Quezon City to submit report as to the condition of existing fire hydrants in their respective jurisdiction so as to guide the Bureau of Fire Protection in the replacement and/or repair of the same, whichever is necessary.

RESOLVED, FURTHER, that the report as to the condition of the fire hydrants in every barangay be submitted to the City Council for proper coordination.
