RESOLUTION NO. SP- 2875 2005

A RESOLUTION URGING THE PHILIPPINE POSTAL CORPORATION TO ESTABLISH A POST OFFICE MAILING CENTER FOR EVERY BARANGAY IN QUEZON CITY.

WHEREAS, the Philippine Postal Corporation is committed to provide the highest quality and widest range of postal services to its customers and is desirous of improving and expanding the mail services by establishing a Barangay Post Office Mailing center in all practicable barangays all over the City;

WHEREAS, the Liga Ng Mga Barangay is vocal and enthusiastic to provide assistance and commits its cooperation with the Philippine Postal Corporation in extending the postal services to the general public through the Barangay Post Office Mailing Centers to be established in the different barangay's citywide;

WHEREAS, pursuant to this objective, the Philippine Postal Corporation shall provide orientation and training to the personnel of the barangay Post Office Mailing Center and concerned Barangay official/s with respect to: One, the proper classification of weighing mails and determining the correct postal charges that shall be levied on mail items; and Two, basic rules on mail services, especially the constitutional mandate of privacy of correspondence or communication;

WHEREAS, the postal transaction shall be limited to the sale of postage stamps and other postal products, and the acceptance of mails through the mail drop box to be designated at the Barangay Post Office Mailing Center;

WHEREAS, upon approval of this Resolution, the Local Postmaster and the Liga Ng Mga Barangay shall forge a Memorandum of Agreement (MOA) in such terms and conditions mutually acceptable and beneficial to both parties.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Philippine Postal Corporation to establish barangay Post Office Mailing Centers in all barangays in Quezon City.

RESOLVED, FURTHER, that copies of this Resolution be furnished to all concerned for their information and guidance.
