A RESOLUTION STRONGLY URGING MEDICAL PRACTITIONERS IN PRIVATE MEDICAL CLINICS, HOSPITALS, AND CLINICAL LABORATORIES IN QUEZON CITY TO REPORT TO THE CITY HEALTH OFFICER ALL CASES OF COMMUNICABLE DISEASES DIAGNOSED AND TREATED IN THEIR FACILITIES WITHIN TWENTY FOUR (24) HOURS AND TO SUBMIT MONTHLY REPORT OF SUCH CASES.

WHEREAS, Section 15 of Article II of the 1987 Philippine Constitution provides that the "State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, there is a need to report all communicable diseases within Quezon City for early public health intervention;

WHEREAS, public health is more of preventive medicine thereby early reporting of cases will enhance immediate intervention to control and prevent occurrence of cases in epidemic proportion;

WHEREAS, the need for the cooperation of both private and public institutions is imperative for public health reasons.



NOW, THEREFORE,




