RESOLUTION NO. SP-2887, S42005

A RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION TO DIRECT THE DIVISION SCHOOL SUPERINTENDENT OF QUEZON CITY TO PARTICIPATE AND ASSIST IN THE CAMPAIGN TO HEIGHTEN ENVIRONMENTAL CONSCIOUSNESS AMONG THE SCHOOL CHILDREN CONCERNED.

WHEREAS, Section 16, Article II of the 1987 Philippine Constitution provides that "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature:

WHEREAS, the City government, is fully aware of the immediate need to adopt a program that would prevent environmental destruction:

WHEREAS, as guilty as the corporations spoiling the environment are the millions of ignorant citizens who damage the forest and pollute the waters;

WHEREAS, the damage to the environment caused by the common people is also visible in the urban centers where citizens dump their wastes into esteros/canals and other waterways which become so shallow that they are flooded after a few minutes of heavy rains;

WHEREAS, the ignorance about environment and ecology points should be addressed, and one way of doing it is by enlightening the school children about these matters.
