RESOLUTION NO. SP-2891, \$1005

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ORGANIZE "BANTAY KRIMEN NG QC" IN CONSULTATION WITH THE LIGA NG MGA BARANGAY OF QUEZON CITY TO SUPPORT AND PROMOTE THE CITY-WIDE CAMPAIGN AGAINST CRIMINALITY.

WHEREAS, the dilemma of widespread criminality, alarming incidence of lawlessness and violence aggravated by the loss of people's trust with seeming inability of the government to meet such problems diminish and erode whatever developmental gains they have so far achieved;

WHEREAS, it will be to the public interest that the government do some concrete actions on this issue, however, the government by itself cannot do it alone, but in the exercise of its police power, it may call upon its people to render assistance for the protection and preservation of public peace and order,

WHEREAS, to achieve a collective and sustained effort in the maintenance of peace and order in this City, the City government has to encourage and enhance public involvement and support in the all-out campaign against criminality.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor Feliciano R. Belmonte, Jr. to organize, in consultation with the Liga ng

mga Barangay in Quezon City, the "Bantay Krimen sa QC" in the City's 142 Barangays, to support and promote the city-wide campaign against criminality under the direct supervision of the Office of the Mayor and in close coordination with the Quezon City Police Station.

RESOLVED, FURTHER, that the City government shall encourage other civic groups to organize their own "Bantay Krimen ng QC" to serve as buffer zone against crime and violence.

RESOLVED, FINALLY, that copy of this Resolution be furnished the Office of the City Mayor and the Chief of Police of Quezon City Police Station.
