A RESOLUTION DIRECTING ALL DEPARTMENT HEADS, EMPLOYEES OF THE CITY GOVERNMENT, BARANGAY CHAIRMEN AND THE MEMBERS OF THEIR RESPECTIVE BARANGAY COUNCILS TO ADOPT, OBSERVE AND IMPLEMENT WAYS AND MEANS TO SAVE ON ELECTRICITY AND WATER CONSUMPTION.

WHEREAS, it has been observed that substantial portion of the city funds is being spent for the payment of electric and water consumption of the city government, its agencies and instrumentalities including barangay halls, playgrounds and other facilities;

WHEREAS, the considerable amount being paid monthly by the City government for its electric and water consumption is a big drain to its budget that sometimes, in order that these vital necessities may not be cut off by Meralco and MWSS, there is a delay in the delivery of basic social services to its constituents;

WHEREAS, these huge monthly bills for electric and water consumption may be greatly reduced and lessened if only all department heads, employees of the City government including all Barangay Chairmen and members of their respective Council will adopt, observe and implement ways and means to reduce electricity and water consumption.
