A RESOLUTION GRANTING AUTHORITY TO HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO PURCHASE A PARCEL OF LOT FOR THE CONSTRUCTION OF A STATE-OF-THE ART REHABILATION CENTER CONDUCIVE AND DESIRABLE FOR THE TREATMENT AND REHABILITATION OF DRUG DEPENDENTS OF QUEZON CITY.

WHEREAS, it has come to an alarming stage, despite efforts exerted by the City government, the ever-increasing in number of drug dependents in Quezon City;

WHEREAS, the approach that must be taken in order to completely achieve a drug-free city is through an effective and holistic Christian drug rehabilitation center;

WI IEREAS, the present Payatas Tahanan Rehabilitation Center seemingly appears not conducive enough in view of its surrounding which can be categorized as a thickly populated residential area, cum City garbage dumpsite;

WHEREAS, Payatas is one of the areas that the City government desires to fully improve as a first class residential area in the city, thus it is mandatory that it be freed from any burden or kinks that will eventually divide the present political and developmental plans of the city government;

WHEREAS, the Tahanan Rehabilitation Center is too small to accommodate the ever-increasing in number of city residents desiring to avail drug rehabilitation treatment;

WHEREAS, the construction of one state-of-the art drug rehabilitation center in a very conducive place combined with holistic and Christian approach becomes mandatory in order to make the city's dream of a drug-free city a reality.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, authority to his Honor, City Mayor Feliciano R. Belmonte, Jr., to purchase, on behalf of the City government, a parcel of lot for the construction of a state-of-the art Christian Oriented Drug Rehabilitation Treatment Center, conducive and desirable for the treatment and rehabilitation of drug dependents of Quezon City.
