RESOLUTION NO. SP- **2926**, S-2005

A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE CONFLAGRATION THAT OCCURRED ON THE 21ST OF JANUARY 2005 AT SITIO LIWANAG, BARANGAY MATANDANG BALARA, QUEZON CITY AND FURTHER AUTHORIZING HIM TO ALLOCATE AND DISBURSE SUCH FINANCIAL AID AS SPECIFIED HEREIN FROM WHATEVER FUNDS OF THE CITY GOVERNMENT WHICH MAY BE AVAILABLE.

WHEREAS, on the 21st of January 2005, a conflagration broke out in Sitio Liwanag, Barangay Matandang Balara, Quezon City and affected a total of forty-one (41) families residing therein, some resulting in a total loss of their homes;

WHEREAS, we, as their representatives and protectors in accordance with the time honored principle of *parens patriae* must do our part to ensure that they receive any bit of assistance that we could give them.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor to extend financial assistance to the victims of the conflagration that occurred on January 21, 2005 at Sitio Liwanag, Barangay Matandang Balara in the amount of Five Thousand Pesos (P5,000.00) for every house owner and Two Thousand Pesos (P2,000.00) for every renter or sharer.

RESOLVED, FURTHER, that the Social Services and Development Department shall determine, through the proper procedure, which were truly affected by the conflagration and thereby worthy of receiving assistance.

RESOLVED, FINALLY, that the City Mayor is hereby authorized to allocate whatever amount as may be necessary for purposes of this measure and release such allocation from whatever fund from the City Treasury that may be available.
