RESOLUTION NO. SP- 2951 "S-2005

A RESOLUTION URGING THE HONORABLE, CITY MAYOR FELICIANO R. BELMONTE, JR. TO HIRE A TECHNICAL EXPERT ON SUBDIVISION LAWS, RULES AND REGULATIONS WHO WILL STUDY THE CITY GOVERNMENT'S TAKEOVER OF ALL ROAD LOTS AND OPEN SPACES WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY, SUBJECT TO ALL LEGAL AND EXISTING RULES AND REGULATIONS.

WHEREAS, Presidential Decrees Nos. 1216 and 957 mandate the subdivision owners or developers to donate or turn over all road lots, alleys, sidewalks and open spaces to the local government unit concerned upon the completion of the project;

WHEREAS, with the orderly and smooth turnover in mind, the City government sees the necessity to engage the services of a technical expert to accordingly advise the City regarding its planned takeover of road lots and open spaces in Quezon City,

WHEREAS, the technical expert will also advise the City on matters relating to use and proper management of all the acquired or taken over properties of the City government.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable, City Mayor Feliciano R. Belmonte, Jr. to hire a technical expert on subdivision laws, rules and regulations who will study the takeover by the City government of all road lots and open spaces within the territorial jurisdiction of Quezon City, subject to all legal and existing rules and regulations.
