A RESOLUTION APPEALING TO HIS HONOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO THE BEREAVED FAMILY OF THE LATE ONOFRE M. CONCEPCION, PUNONG BARANGAY FOR TWO (2) TERMS OF BARANGAY TAGUMPAY, DISTRICT III, QUEZON CITY WHO DIED OF HEART ATTACK LAST NOVEMBER 15, 2003.

WHEREAS, there is a need for the City government to give the amount of Forty Thousand Pesos (P40,000.00) to show gratitude and recognition to the untainted and unselfish public service of the deceased as Barangay Kagawad in 1994 and Punong Barangay, two (2) terms, from 1995 to 2000 of Barangay Tagumpay, District III, Quezon City.


