RESOLUTION STRONGLY APPEALING TO HIS HONOR FELICIANO R. BELMONTE. JR., FINANCIAL TO GRANT ASSISTANCE IN THE AMOUNT OF TWENTY THOUSAND PESOS (P20,000.00) TO THE FAMILY OF THE LATE JAIME B. CLEOFE FORMER BARANGAY CAPTAIN AND KAGAWAD OF BARANGAY SILANGAN, DISTRICT III, QUEZON CITY AS A TOKEN OF RECOGNITION THE OF. CITY GOVERNMENT FOR INVALUABLE LONG YEARS OF PUBLIC SERVICE RENDERED.

WHEREAS, the late Jaime B. Cleofe has started rendering public service to the residents of Silangan Village, (now Barangay Silangan) Quezon City since 1960 as Tinyente del Barrio and was elected as Kapitan del Barrio in 1972;

WHEREAS, because of dedication and sincere performance and insistent demand of the residents for the late Jaime B. Cleofe's continuous service, the call of duty prevailed upon over his personal welfare, thus he was re-elected on the same position on 1982 and stayed in his office until 1989;

WHEREAS, to help and serve the people of Barangay Silangan has become a part of his personal life and commitment, he ran for the position of Barangay Kagawad, because he was no longer qualified to run for the same position as Punong Barangay, where he was elected also;

Cleofe.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to appeal, as it does hereby strongly appeal, to his Honor Feliciano R. Belmonte, Jr., to grant financial assistance in the amount of Twenty Thousand Pesos (P20,000.00) to the family of the late Jaime B. Cleofe former Barangay Captain and Kagawad of Barangay Silangan, District III, Quezon City as a token of recognition of the City government for his invaluable long years of public service rendered.

RESOLVED, FURTHER, that copy of the resolution be forwarded to the Office of the City Mayor, and to concerned offices for information and appropriate action.
