A RESOLUTION STRONGLY URGING THE PEDESTRIANS TO UTILIZE THE FOOTBRIDGE WHENEVER CROSSING ANY STREET IN QUEZON CITY.

WHEREAS, under Section 16 Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod may, for public safety and welfare, enact ordinances regulating the use of streets, avenues, alleys, sidewalks, and bridges, among others;

WHEREAS, the Metro Manila Development Authority (MMDA) had recently installed footbridges in Quezon City in addition to the existing overpass built within the City, for the safety and comfort of the pedestrians;

WHEREAS, pedestrians should be required to use the footbridges in crossing any street or intersection in Quezon City, where these infrastructure are available, so that they will no longer have to compete with vehicles for road space as well as traffic signal time thus reducing traffic congestion and traffic accidents involving pedestrians in these areas.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the pedestrians to utilize the footbridge whenever crossing any street in Quezon City.
