RESOLUTION NO. SP-3030 . , \$-2005 (PR2005-220)

A RESOLUTION URGING MANUFACTURERS AND/OR TRADERS ENGAGED IN THE SALE OR DISTRIBUTION OF LIQUEFIED PETROLEUM GAS (LPG) TANKS OR CYLINDERS AND OTHER HIGHLY COMBUSTIBLE SUBSTANCES IN QUEZON CITY NOT TO DISPLAY LPG TANKS AND CONTAINERS OF OTHER COMBUSTIBLE SUBSTANCES ALONG SIDEWALKS AND STREETS WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY.

WHEREAS, one of the major causes of fire or mass destruction is the explosion of liquefied petroleum gas (LPG) tanks or cylinders and other highly combustible substances;

WHEREAS, it has been observed that some manufacturers, traders or sellers of these LPG tanks or cylinders and other highly combustible substances in the city wantonly display said tanks and containers, whether full or empty, in front of their business premises while others, majority of them actually place their wares along sidewalks and streets, posing grave danger to the health, safety and security of the public, aside from impeding the flow of pedestrian along these streets and sidewalks, thereby raising serious concerns not only on the part of the public but also from the local officials;

WHEREAS, under Section 16 of the Local Government Code of 1991, otherwise known as the "General Welfare Clause", local government officials particularly the concerned members of the local sanggunian are empowered to enact laws that will promote the general welfare;

WHEREAS, the passage of this resolution regulating the display of LPG tanks and containers of other combustible substances along sidewalks and streets will certainly ensure the health and safety of the public and provide essential means for the prevention of fire that can cause mass destruction.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, manufacturers and/or traders engaged in the sale or distribution of liquefied petroleum gas (LPG) tanks or cylinders and other highly combustible substances in Quezon City not to display LPG tanks and containers of other combustible substances along sidewalks and streets within the territorial jurisdiction of Quezon City.
