RESOLUTION NO. SP-3048, S-2005 (PR2005-299)

A RESOLUTION URGING HONORABLE VINCENT P. CRISOLOGO, REPRESENTATIVE OF THE FIRST DISTRICT OF QUEZON CITY, TO CONSTRUCT A MONUMENT IN HONOR OF THE LATE HONORABLE REYNALDO A. CALALAY, THE FORMER'S PREDECESSOR IN OFFICE, AT THE CORNER OF ROOSEVELT AND CONGRESSIONAL AVENUES.

WHEREAS, the late Honorable Reynaldo A. Calalay, former Councilor and Representative of the First District of Quezon City, had long and faithfully served his constituents in Quezon City until his untimely demise in 2004;

WHEREAS, the Sangguniang Panlungsod of Quezon City passed Resolution No. SP-2121, Series of 2003 "urging the Congress of the Philippines to rename either Del Monte Avenue or Roosevelt Avenue, 1st District, Quezon City to Reynaldo A. Calalay Avenue" as an expression of gratitude to Representative Calalay who selflessly devoted himself to a stellar career public service;

WHEREAS, Honorable Vincent P. Crisologo had expressed an intention to construct a monument in honor of the late Representative Calalay at the corner of Del Monte and Roosevelt Avenues and requests the passage of the pertinent resolution by the Sannguniang Panlungsod of Quezon City which authorizes him to do so;
