A RESOLUTION EXPRESSING SUPPORT TO HER EXCELLENCY, PRESIDENT GLORIA MACAPAGAL-ARROYO AND HER ADMINISTRATION.

WHEREAS, the nation today faces a colossal political crisis which traces its origin from malicious and unsubstantial allegations of misconduct allegedly perpetrated through a harmless telephone conversation between Her Excellency, President Gloria Macapagal-Arroyo, and an unidentified commissioner of the Commission on Election;

WHEREAS, such allegation of misconduct involving no less than the highest official of the land naturally metamorphosed — with the aid of a curious press — into a controversy which was also naturally immediately swallowed by persons who hunger for undue power and a misinformed few,

WHEREAS, previously, the Mayor of the Local Government of Quezon City, the Honorable Feliciano R. Belmonte, Jr., along with other local chief executives from Metro Manila and other parts of the country held a press conference expressing their full support to President Gloria Macapagal-Arroyo and her current administration;



WHEREAS, the foundation of our republican, democratic and constitutional State and its institutions, the Constitution itself, should prevail and be upheld against belligerent attacks;

WHEREAS, any means of removal of an incumbent President, the Head of State and the Government, which is repugnant to the Constitution would assuredly result not only to a political but an all-encompassing national, including economic crisis;

WHEREAS, it is time to move on towards economic recovery that has been hampered by the present crisis;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to express support, as it does hereby express support, to Her Excellency, President Cloria Macapagal-Arroyo, her administration and the rule of law.
