RESOLUTION NO. SP. 3060, \$2005 (PR2005-328)

A RESOLUTION AUTHORIZING THE REPAIR OF THE CANAL ALONG BAYAN STREET, BARANGAY BUNGAD, FIRST DISTRICT, QUEZON CITY, APPROPRIATING THE NECESSARY FUNDS, AND FOR OTHER PURPOSES.

WHEREAS, residents within the vicinity of Bayan Street, Barangay Bungad, First District, Quezon City, experience flashflood during heavy downpour of rains, causing not only damage to property but worse, deep anxiety to those who are affected;

WHEREAS, the canal along Bayan Street is reasonably suspected to be clogged which causes the aforesaid flashflood;

WHEREAS, Mr. Jose Vargas, a resident of Barangay Bungad, who is among those affected by the flashflood sent a letter dated 25 June 2005 to the Sangguniang Panlungsod of the local government of Quezon City and all others concerned, lamenting the ordeal that they suffered and suggesting the repair of the aforesaid canal;

- Kung makabubuti na open canal lang ito para maiwasang may maglagay ng basura at ipapadaloy lamang sa tubig.

Umaasa po kami sa tulong ninyo sa aming barangay. Maraming Salamat po.

WHEREAS, the "General Welfare Clause" of Republic Act No. 7160, otherwise referred to as the Local Government Code of 1991, provides:

"SECTION 16. General Welfare. – Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidentals for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to balance ecology,



encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, the infrastructural problem at hand cries out for action and remedy from the public service.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the repair of the canal along Bayan Street, Barangay Bungad, First District, Quezon City, appropriating the necessary funds from any available funds of the City Treasury of the local government.
