A RESOLUTION AUTHORIZING THE CITY HEALTH OFFICER TO MAKE REPRESENTATIONS BEFORE THE HONORABLE SENATOR MANUELITO LAPID TO INCLUDE QUEZON CITY AS A BENEFICIARY OF HIS DISTRIBUTION PROJECT.

WHEREAS, among the serious concerns of our City Health Office is the lack of and/or insufficient supply of various types of medicine for the indigent citizens of the City who come to the various health centers for treatment;

WHEREAS, there were information received that the Honorable Senator Manuelito Lapid had embarked in a medicine distribution project for the benefit of various cities, municipalities and provinces;

WHEREAS, the project of the Honorable Senator Manuelito Lapid could bring enormous relief to the indigent constituents of Quezon City who can be counted in as a beneficiary of the medicine distributions project;

WHEREAS, pursuant to Section 478 (4) (viii) of the Local Government Code of 1991, the City Health Officer, in addition to his duties and functions shall, coordinate with other government agencies and non-governmental organizations involved in the promotion and delivery of health services;

WHEREAS, official representation must be made in order to request the office of the Honorable Senator Manuelito Lapid to include Quezon City as a beneficiary of the medicine distribution project.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Health Officer to make representations before the Honorable Senator Manuelito Lapid to include Quezon City as a beneficiary of his distribution project.

RESOLVED, FURTHER, that the medicines distributed which the Honorable Senator Manuelito Lapid would donate to Quezon City shall be equitably distributed to the various health centers of the one hundred forty two (142) barangays of Quezon City which shall be under the direct supervision and control of the City Health Office.
